

The Malling School GB – Information for the school website – July 2023

The Governing Body of The Malling School comprises 12 governors in total. The membership is made up as follows:

- 2 Parent Governors – Parents/Carers of registered students at the School, elected by the parent body
- 1 Local Authority Governor – Nominated by the Local Authority and appointed by the Governing Body
- 1 Staff Governor – A member of teaching or support staff at the School, elected by the staff body
- 1 Headteacher Governor – The Headteacher of the School
- 5 Co-opted Governors – Governors appointed by the Governing Body to make sure the school has the skills and experience that it needs
- 2 Partnership Governors – Appointed by the Governing Body through a nomination process

The Governing Body operates through the Circle Model, without Committees. Details of the current membership and membership over the past 12 months together with attendance for the year 2022/23 are set out below:
